SIGNAGE COST & DELIVERY INFORMATION

- The cost of each sign is \$247.89, plus applicable sales tax and supplier shipping charges.
- A \$60 delivery fee per property will be applied for Chain Gang Towing & Recovery Agency LLC to transport the completed signage from our facility to the designated property. This fee applies to each individual property serviced, regardless of common ownership.
- If property management chooses to pick up the signage directly from our facility, the \$60 delivery fee will be waived.

- ☐ **2. AUTHORIZATION TO TOW**
The Property authorizes Chain Gang Towing & Recovery Agency LLC to remove and store vehicles parked in violation of posted parking restrictions, lease terms, or property rules, or identified by Property Management as unauthorized. This authorization includes 24-hour enforcement unless otherwise limited in writing.
- ☐ **3. RELIANCE ON PROPERTY MANAGEMENT REPRESENTATIONS**
The Towing Company may rely on Property Management's representations regarding vehicle authorization. Property Management assumes responsibility for errors in identifying authorized vehicles, including guests.
- ☐ **4. SIGNAGE & REIMBURSEMENT**
The Property confirms all required private-property towing signage complies with New Jersey law. Any signage purchased by Chain Gang Towing & Recovery Agency LLC shall be reimbursed in full by the Property.
- ☐ **5. FEES & CHARGES**
Towing and storage fees are established in compliance with New Jersey Division of Consumer Affairs regulations and are charged to the vehicle owner at the time of vehicle release.
- ☐ **6. INDEMNIFICATION**
The Property agrees to defend, indemnify, and hold harmless Chain Gang Towing & Recovery Agency LLC from claims, disputes, damages, refunds, losses, or legal actions arising from enforcement decisions, except where caused by gross negligence or willful misconduct.
- ☐ **7. EMAIL NOTICE REQUIREMENT**
All towing requests, authorization changes, disputes, or revocations must be communicated in writing via email to chaingangimpound@gmail.com. Verbal notices shall not modify this Agreement.
- ☐ **8. TERM & CANCELLATION**
This Agreement remains in effect unless canceled with no less than thirty (30) days written notice delivered by email. Cancellation does not affect prior tows or signage reimbursement obligations.
- ☐ **9. GOVERNING LAW**
This Agreement shall be governed by and construed in accordance with the laws of the State of New Jersey.
